I, the President of AUGUSTA LANDING CONDOMINIUM ASSOCIATION, INC., a Texas non-profit corporation organized under the Texas Non-Profit Corporation Act, do hereby certify that a regular meeting of the Board of Directors was held on the 17 day of August, 2023, with a majority of Directors being present and remaining throughout and being duly authorized to transact business, the follow resolution was duly made and approved:

Whereas, Augusta Landing Condominium Association, Inc. (the "Association") is charged by the Declaration of Covenants, Conditions and Restrictions for Augusta Landing (the "Declaration") with the responsibility of vigorously enforcing the covenants, by-laws and regulations of the Association (the "Governing Documents"); and

Whereas, the Board of Directors of Augusta Landing Condominium Association, Inc. (the "Board") wishes to memorialize in its minutes its policy in the event of violations of the Governing Documents by the Owners. This policy is in addition to the policies set out in the covenants, by-laws and regulations of the Association; and Whereas,


The Board desires to establish a fine policy in accordance with Section 204 of the Texas Property Code;

Now therefore be it resolved that any Owners not timely correcting violations after a First Letter from the management company will be subject to the following:

First Letter	No Charge
Second Letter	\$25.00 Fine
Third Letter	\$35.00 Fine
Final 209 Letter	\$75.00 Fine

This Policy is effective upon recordation in the Public Records of Harris County, Texas. Except as affected by Section 209.0062 and/or by this Policy, all other provisions contained in the Declaration or any other dedicatory instruments of the Association shall remain in full force and effect.



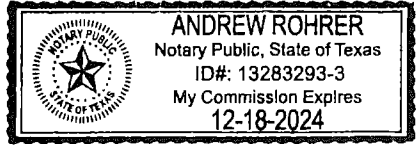
