### CERTIFICATE OF FORMATION

#### ARTICLE ONE

#### ARTICLE SIX

No Director of the Corporation shall be liable to the Corporation or its Members for monetary damages for an act or omission in the Director's capacity as a governing person, except for liability (i) for a breach of the Director's duty of loyalty to the Corporation, or its Members, (ii) for acts or omissions not in good faith that constitute a breach of duty of the Director to the Corporation or that involve intentional misconduct or a knowing violation of the law, (iii) a transaction from which the Director received an improper benefit, whether or not the benefit resulted from an act taken within the scope of the Director's office, or (iv) for acts or omissions for which the liability of a governing person is expressly provided by statute. Any repeal or amendment of this Article by the Members of the Corporation shall be prospective only, and shall not adversely affect any limitation on the personal liability of a Director of the Corporation existing at the time of such repeal or amendment.

#### ARTICLE SEVEN

The undersigned Organizer hereby disclaims any past or future interests in or control of Brentwood Villas Property Owners' Association, Inc. and resigns as the Organizer effective upon the formation of the Corporation.
