ARTICLES OF INCORPORATION

GREENNAY DAKS OWNERS ASSOCIATION. INC.

The be amended from time to time as therein provided, said Declaration being incorporated herein as if set forth at length, and to have and to exercise any and all powers, rights and privileges which a corporation organized under the Hon-Profit Corporation Law of the State of Texas by law may now or hereafter have to exercise.

ARTICLE V

The street address of the initial registered office of the corporation is 1770 St. James Place, Suite 404, Houston, Texas 77056, and the name of its initial registered agent at such address is LEO V. McCORNELL.

ARTICLE VI

Every person or entity who is a record owner of a few or undivided fee interest in any condominium unit which is subject by the Declaration to assessment of the Association including contract sellers shall be a member of the Association and shall be entitled to one vote for each unit owned, the value of such vote shall be equal to the percentage interest assigned to each such unit as set forth in the Declaration. When more than one person holds an interest in any unit, all such persons shall be members. The vote for such unit shall be exercised as they among themselves determine, but in no event shall more than one vote be cast with respect to any unit. The foregoing is not intended to include persons or entities who hold an interest merely as security for the performance of an obligation. Memberships shall be appurtunant to and may not be separated from ownership of any unit which is subject to assessment by the Association.
