Houston Augusta Green Rules and Regulations

Parking:

- 1. Guest parking is for guests only. Residents parking in guest parking are subject to tow without notice.
- 2. Guest parking is only for 48 hours any car parked longer is subject to tow without notice.
- 3. No derelict cars, leaking oil, flat tire(s), missing headlights or taillights or anything that could render a car inoperable is subject to tow without notice.
- 4. Any car parked in a fire lane is subject to immediate tow without notice.
- 5. Any car blocking access to another unit's garage may be subject to tow without notice.

Landscape / exterior change:

- 1. Any change made to the exterior of the home without approval is subject to fees and or fines.
- 2. Residents are not allowed to place items on walkways or driveways.

Water use:

1. Washing of cars is prohibited, violators will be subject to notices and fines.

Balconies:

- 1. No items are to be hung over the side wall or left in public view.
- 2. No large, weighted items such as planters, umbrellas or grills are allowed on balconies.
- 3. No drying of clothes.

Trash:

- 1. Trash is to be left out no earlier than sundown the night before pickup.
- 2. Trash must be left in bags; no containers can be used, and bags must be securely tied any container used will be taken with trash.

Objects in windows:

- 1. No unit shall post any advertisement or poster of any kind in public view.
- 2. Residents are not allowed to hang items outside of a window.
- 3. Window coverings must be a neutral color.
- 4. Broken window blinds are not allowed.

Pets:

- 1. Residents are not allowed to have more than 2 dogs or cats.
- 2. Residents must pick up after animals.
- 3. Animals deemed aggressive are not allowed on property.
- 4. Animals are not allowed in the pool area.

Noise:

Owners are to obey City of Houston noise ordinances laws.
