# **Rules & Regulations**

#### <u>Acknowledgement</u>

The following sections were duly adopted on May 30, 2018 by the Board of Directors of Chelsea at Mission Bend Community Association, Inc., located in Fort Bend County. The authority to adopt and modify these rules and regulations are duly noted in the Declarations of Covenants, Conditions and Restrictions of Chelsea at Mission Bend and its By-Laws. Each lot owner in the community, together with their families, guests, occupants, and tenants are subject to these Rules and Regulations.

#### PROHIBITION OF OFFENSIVE ACTIVITIES

No noxious or offensive activity of any sort shall be permitted nor shall anything be done on any lot which may be or become an annoyance or a nuisance to the neighborhood. Owners having parties on their lots are responsible for the actions of their guests and if their guests trash the community by discording beer cans, liquor bottles, food items, or any other trash; it is the responsibility of the lot owner(s) to clean-up all discorded trash immediately after the conclusion of their party, or not later than noon time (12:00 PM) the next day. If not, then the HOA has the right to hire a clean-up crew and chargeback all expenses to the owner having the party.

Owners celebrating by popping firecrackers during holidays or any other times are responsible to clean-up all debris immediately after the celebration, or not later than noon time (12:00 PM) the next day. If not, then the HOA has the right to hire a clean-up crew and chargeback all expenses to the owner(s) popping firecrackers. Additionally, owners are limited to celebrating on their lot or the front of their homes <u>only</u> and may not move to other locations in an attempt to be near a street light. Further, no firecrackers or other loud noises should exceed 12:00 AM through the week and not later than 1:00 AM on weekends.

Bar-b-cue pits are not allowed in the front yard or driveways. All cooking should be done in the backyard of each fenced lot.

#### Lot Maintenance

In addition to mowing/edging lawns frequently, owners must remove all dead plants and trees from lots. Flower beds should be cleared of weeds and other debris (such as broken loose tree branches) which float into the streets during heavy rain and blocks street drains. This caused water to flood the streets and backup into the yards and could flood homes.

Homes should be painted so as not to show chipped or fading paint from wood or hardiplank surfaces. Exterior surfaces of homes should be power washed to remove black or green mold/mildew.

Window screens and storm doors should be in excellent appearances.

Driveways should be free of oil leaks/stains, and no inoperable vehicles (with or without current registration) are allowed to be stored on any lot.

There should be no graffiti on any sidewalk/driveway or walls from color crayons, paints, etc.
